- LATE DELIVERY:** the applicant shall not cancel an order due to late delivery unless the supplier has been notified in writing prior to shipment.
- RETURNS:** No merchandise may be returned without prior written authorization of the supplier.
- REFUSAL TO SHIP:** The supplier may refuse to ship any confirmed order in whole or in part for any reason it deems sufficient.
- OWNERSHIP OF PRODUCTS:** Unless otherwise agreed to in writing, the supplier retains ownership (Security Interest) of all merchandise shipped until paid for in full by the applicant.
